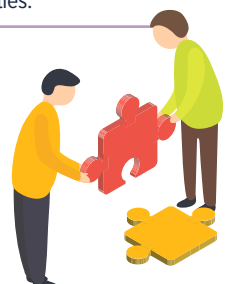

2:10 Fostering Defence-Relevant Collaborative Research & Development: Successes and Challenges

Presenter: *Sumen Rai, Associate Director, Engagement, Defence Innovation Partnership*

Description: The Defence Innovation Partnership was established to build and support collaborative defence-relevant research and development activities in South Australia. Over the last two years, DIP has facilitated and funded collaborative teams across the three South Australian Universities, industry and government, with successes and challenges along the way. DIP is also encouraging transdisciplinary engagement across these stakeholder groups through the Convergence Series events, to broaden and diversify the 'defence research and development' community and bring the best teams together to address complex challenges with defence and national security implications. 3:50 Cyber Resilience in South Australia: A Perspective from the SA Government

Presenters: *Will Luker & Michael Billett, Office for Cyber Security, Department of the Premier and Cabinet, Government of South Australia*

Description: State and Local Governments own and manage a range of information technology infrastructure, services and systems on behalf of the citizens of South Australia. In order to uphold citizen's trust and confidence, and to ensure services delivered to the community are reliable and resilient, it is imperative that we safeguard infrastructure, digital assets and citizen information against cyber threats. The Office for Cyber Security in the Department of the Premier and Cabinet are the lead agency for cyber security in the South Australian Government and the Office is tasked with the responsibility of leading the SA Government's approach to cyber security including major incident response as part of the state's emergency management arrangements. This presentation will provide an overview of the SA Government's approach to Cyber Security from the launch of the first Cyber Security Strategic Plan to the soon to be released Cyber Security Framework. Will Luker and Michael Billett will draw on their experiences in cyber resilience and emergency response to provide perspectives and learnings from SA Government and reflect on how Local, State and Federal Governments can work more closely together with the private sector to respond to an ever changing cyber threat landscape.

4:30 How Vulnerability Fosters Collaboration

Presenter: *Steph Jeuken, Principal Consultant, EAI Projects*

Description: Collaboration seems to be the go-to phrase in organisations these days but the question is: what are organisations doing to build this culture, encourage collaboration and reap the benefits in performance? Organisations seek to create high-performing, collaborative workplace cultures but often forget that this requires providing a place where people feel safe, have the time and space to deeply connect and co-create value, and have permission to freely share their ideas, wisdom, knowledge, information, resources, and perspectives. What changes within an organisation will allow leaders to shift their focus from defensive competition to constructive collaboration? Steph will explore the idea of how leadership provides the boundaries, but it's the people within the organisation that actually create the environment. The employees play the game the leadership merely establish and encourage the rules of that game. Steph will discuss the traits of a truly collaborative workplace – guidelines that breed collaboration and the tricky bits about fostering a following within the organisation and getting the team behind the new set of rules.
