# 1:30 Artificial Intelligence - new opportunities, new risks

#### **Description:**

Generative AI is one of the most significant technologies of the moment, with expansion and utilisation forecast to grow at an exponential rate. While it provides exciting opportunities for the public and private sector, there are significant legal and security risks associated with its use. Given the breadth of applications for AI, it is difficult to point to any single law or set of laws that are relevant for Australian AI users and developers. In any given project a myriad of laws may be relevant. This presentation will explore the key legal risks and considerations you should be aware of when using generative AI.


